**Call to order 8:06 am**- Nick makes a motion to accept minutes from November 2015 midyear board meeting at Austin Pay University. Ken seconds. Approved by the board 8-0.

**Retiree Membership – Steve Mangione –** Steve reports that retiree membership is falling off. Also looking into the possibility of eliminating the newsletter and going to an online blog instead. Not enough members are contributing content

Website Update - Ken Bennett and Glenn Carpenter - Trellon has been very quick to help resolve issues. Most of the problems stem from database issues. The original person from Trellon that handled all of this has left the company which has complicated everything. They continue to fix bugs for free. We do have a contract with them to make improvements throughout the year. The member dash bar will be updated. This will make it easier to search for members who will be accepting freelance jobs. We need to update the shopping cart to make usable receipts and invoices. Ken mentioned that members would like to see an updated contest module so people who do not win awards will still be able to see how they place. Ken also mentioned that he would like to see the website automatically update winners photos each month. The board then voted 8-0 in favor of granting Trellon and additional contract for more improvements.
